## Fighter Eligibility Requirements

- ✓ Must be licensed with **WA State Department of Licensing (DOL)**
  - ✓ Must have:
    - Valid **Athlete License** (WA DOL)
    - Current **medical exam** on file
    - Negative **bloodwork** (HIV, Hep B, Hep C) dated within 180 days of event
  - ✓ Submit full **participant info** (name, discipline, weight class, license #) by **September 10, 2025**
  - ✓ **Personal insurance** for participating fighters (recommended)
  - ✓ **\$10,000 accidental death & \$10,000 medical coverage** provided by event promoter

## Fight/Event Safety Requirements

- WA DOL-licensed **promoter** and **event permit** must be in place
  - Licensed **referees, judges, inspectors** present
  - **Ringside physician** and **EMS** required on-site
  - **Fighter safety gear** (mouthguards, wraps, gloves) checked before match
  - Crowd barriers must be respected at all times

## Match Regulations

- Kun Khmer & Muay Thai governed by WA DOL rules (exhibition rules)
  - Participants must comply with match schedules, weight classes, and pre-bout checks
- 

## Insurance & Liability

Promoter will carry:

- **\$1M liability insurance**
- **\$10K accidental death insurance per athlete**
- **\$10K medical coverage per athlete**

Additional insured:

- WA Department of Licensing
  - City of Seattle
  - King County
  - WCCDA, CACCWA, USEACA, Eazy Duz It

## Important Dates

Deadline	Requirement
<b>Aug 25</b>	Promoter submits event permit (WA DOL)
<b>Sept 10</b>	All athletes licensed, medical/bloodwork complete
<b>Sept 22</b>	Final fight card and participant list released
